Application for Membership and Subscription Agreement

I. APPLICATION FOR MEMBERSHIP AND REPRESENTATIONS

I hereby apply for membership and subscribe for and agree to purchase one (1) share of Membership Stock, at a price of \$100.00 per share. In addition, if I enter into agreement with a DLGC-Approved Packer(s) (eg., Superior Farms), I agree to purchase a minimum of 50 shares of Equity Stock of Dakota Lamb Growers Cooperative(the "Cooperative") from a current member of Dakota Lamb Growers at a price to be determined between the buyer and seller. If I intend to enter into an agreement with a DLGC Value Added Provider, I agree to purchase a number of Equity Shares equal to the number of lambs delivered to the Value Added Provider in one calendar year, until I own a minimum of 50 DLGC Equity Shares.

With the return of the completed Subscription Agreement, I agree to make an initial payment in an amount equal to \$100 for the Membership Share. I hereby declare and represent to the Cooperative that:

- 1, I am at least eighteen (18) years old and have the legal authority to execute this Subscription Agreement.
- 2. I represent that the investment in the Shares is a suitable investment for me, taking into consideration the risks and the restrictions on transferability thereof. I agree that I will not dispose of the Shares or any interest therein, unless and until (i) counsel for the Cooperative, in its sole discretion, shall have determined, by obtaining an opinion of my counsel or otherwise, that the intended disposition does not violate any applicable state securities law or the Act or the rules and regulations of the Securities and Exchange Commission thereunder, or (ii) the Shares have been validly registered with the Securities and Exchange Commission.
- 3. I am a sheep producer.
- 4. I have the opportunity to review the Cooperative's Articles of Association, Bylaws, and Uniform Marketing Agreement which can be found on the Cooperative's website at www.dakotalambgrowers.com and agree to be bound by them in all respects and consent to include all qualified allocated patronage dividends and per unit retains (both cash and certificate) as income for income tax purposes.
- 5. I understand that my ownership of the share of Membership Stock entitles me to one (1) vote on all matters submitted to a vote of the membership and the Equity Shares are non-voting.
- 6. I agree to comply with all present and future eligibility requirements for membership and to abide by rules and policies of uniform application as adopted by the Board of Directors.
- 7. I acknowledge that a member's membership in the Cooperative may be terminated in the event that the member becomes ineligible for membership as provided for in the Bylaws of the Cooperative.
- 8. The undersigned has been given the opportunity to ask questions of the Cooperative's Board of Directors and its consultants, and has been given access to any and all information available to those persons in connection with the Cooperative.

II. AGREEMENT TO BE BOUND BY UNIFORM MARKETING AGREEMENT

Uniform Marketing Agreement

By the execution of this Subscription Agreement, and upon its full or partial acceptance by the Cooperative, the undersigned is also deemed to have executed the Uniform Marketing Agreement, and agrees to be bound in all respects by that Uniform Marketing Agreement to the same effect and purpose as if the undersigned's signature were applied to that agreement (as it may be amended from time to time.)

III. MATTERS TO BE COMPLETED BY SUBSCRIBER

A. Equity Shares (Please complete)

Each share of Equity Stock entitles me to deliver one (1) finished lamb to the Cooperative in accordance with the Uniform Marketing Agreement and contractual specifications of the Approved Packer and Value Added Provider.
